I agree that North Pacific Fuel shall not be liable or responsible for any inadequate supply of fuel in the event of sudden changes in consumption without reasonable notice to North Pacific Fuel, or due to leaks or other loss of fuels not caused by negligence on the part of North Pacific Fuel. I understand if we utilize wood stoves or sources of heat other than oil, an in-terruption of such use (i.e. mid-winter vacation and/or discontinued use of wood or supplemental heating source) will result in an increase in my oil consumption. I agree to give written notice to North Pacific Fuel prior to any interruption.

In the event I wish to terminate Keep Full Service, I agree to give North Pacific Fuel written notice. If notice is given by mail, it will be sent Certified or Registered Mail only. Notice of cancellation shall only be effective when received by North Pacific Fuel, as determined by the return mail receipt. I agree to pay, within ten (10) days of invoice, for all fuel delivered prior to or on the same day as notice of cancellation was received by North Pacific Fuel.

I FURTHER AGREE NORTH PACIFIC FUEL SHALL NOT BE LIABLE FOR NONANY REASON BEYOND ITS CONTROL, INCLUDING WITHOUT LIMITATION PRODUCT SHORTAGE, STRIKES OR WORK STOPPAGES OR SLOWDOWNS, OR WEATHER, OR IF NORTH PACIFIC FUEL HALTS DELIVERY BECAUSE OF MY FAILURE TO NOTIFY NORTH PACIFIC FUEL OF THE TIMES AND DATES THE DWELLING WILL BE VACANT FOR ANY PERIOD OF TIME OR OF ANY FACTOR THAT WILL ALTER NORMAL FUEL USAGE, FAILURE TO MAKE PAYMENTS ON ACCOUNT OR FAILURE TO COMPLY WITH ANY OTHER AGREEMENT WITH NORTH PACIFIC FUEL.
